No signature chargeback protection is offered to specific industry segments when certain conditions are met. The below table outlines eligible MCC's and maximum amounts where a signature is not required for transactions that contain the full un-altered contents of a Mag-stripe or Chip in the

authorization request. Additional requirements are outlined below by card association.

When the Contactless Indicator is enabled in a merchant file they will be automatically registered with Visa

No Signature Required program applies to ANY MCC for contactless **payWave** and Mag-stripe transactions as long as a Contactless reader is attached and the merchant has previously processed contactless transactions.
